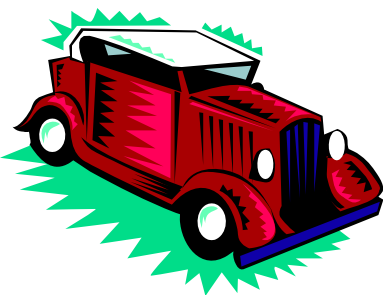
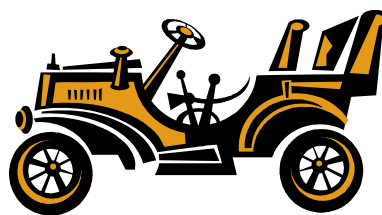

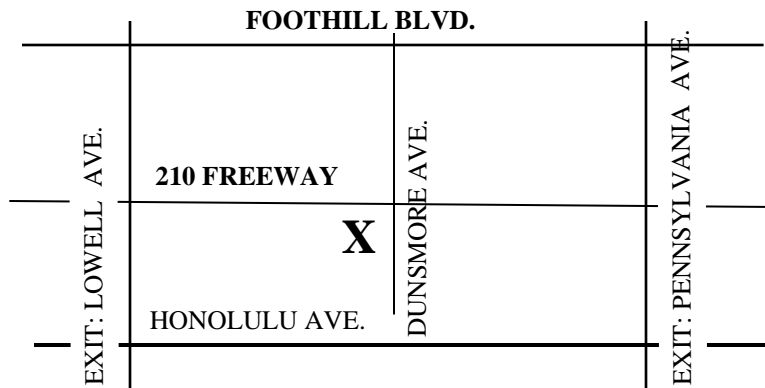
## Trophies to be awarded
