EXPO RULES AND REGULATIONS

APPLICATIONS

Application for the exhibit space will be subject to the approval of the Expo Committee. Only Chamber members in good standing will be allowed to contract for space. If you are interested in contracting space and are currently not a member, you must join a hosting Chamber. Full payment for each exhibit space is required at time of application to confirm the reservation. **After processing, no cancellations will be accepted or refunds given.** **Subleasing of space is prohibited. The Expo Committee will assign exhibit space based on receipt date and availability.**

SPACE REGULATIONS

Exhibit space must remain staffed at all times during the Expo. **Dismantling of displays cannot commence until 7:30p.m.** Those exhibitors who take down their displays prior to that time will forfeit their prime booth space for the following year. No exhibits or non-related materials bearing any name other than the contracted exhibitor may be displayed. Space dimensions are standard and strictly enforced. Exhibitors must conform to all rules and regulations in effect at USC Verdugo Hills Hospital as set forth by the fire department, police department and/or building and safety departments. No bolts, screws, hooks, tape or nails are to be driven into or attached to the walls or floors. Violators will be responsible for removal of any stick-on materials and any charge for clean-up or repair. Exhibitor will at no time permit either refuse or portions of his exhibit to obstruct any aisle or remain within the confines of exhibit space. No exhibitor is permitted to erect signs or display products in such a manner as to obstruct view, to cause injury or adversely affect the displays of other exhibitors. Exhibitors and their employees must confine their activities to the booth space(s). Handouts, including literature, souvenir items and any and all promotional materials may be distributed only for exhibitor space(s). Literature and/or promotional material cannot be handed out, left for display or otherwise distributed in any area other than the contracted space.

BOOTH DISPLAY REGULATIONS

To conform to USC VHH regulations, glitter, confetti, popcorn, kettle corn and similar items are **prohibited** from use.

SAFETY AND SECURITY

Exhibitors are cautioned and instructed to avoid blocking fire-fighting equipment. The Chambers and USC Verdugo Hills Hospital assume no responsibility for goods delivered to the location or material left in the building.

LIABILITY

Each exhibitor indemnifies and holds harmless the following entities: USC Verdugo Hills Hospital, Crescenta Valley, La Cañada Flintridge, & Montrose-Verdugo City Chambers of Commerce. Exhibitors must not damage or deface property, and are liable for such actions. Neither the Chamber and/or its sponsors, agents, staff or volunteers, USC Verdugo Hills Hospital, UCS Verdugo Hills Hospital Foundation, their representatives or any member or employee of the Expo is responsible for injury, loss or damage from any cause whatsoever that may be suffered by any exhibitor, their employees or property. The exhibitor, upon execution of the contract expressly releases the foregoing named Chambers of Commerce and USC Verdugo Hills Hospital parties, individuals and employees from any and all claims for such loss, damage, or injury. Any and all restrictions and/or levies enforced or imposed by USC Verdugo Hills Hospital, the Chambers, the City of Glendale and/or the State of California, must be observed.

PARKING

Exhibitor and visitor parking is available **exclusively** on the upper level parking structure. Additional free parking is available in the surrounding parking lots at USC Verdugo Hills Hospital.

EXPO COMMITTEE RIGHTS

The Chambers reserve the right to terminate or reassign exhibit space that is not occupied by 3 p.m. The Expo Committee reserves the right to deem material or literature inappropriate and may ask for removal. Questions, comments or concerns may be directed to the member's Chamber of Commerce office.

EXPO VENDOR LIST

Each attendee will receive an Expo Vendor List showing the booth location of each individual vendor.

Whereas, on September 12, 2018, three regional Chambers of Commerce and USC Verdugo Hills Hospital will sponsor a Community Event, henceforth called Foothills Community Business Expo. Exhibit space will be reserved on a first come first served basis and is subject to the approval of the Expo Committee. The undersigned has entered into an agreement with the Expo Committee to maintain booth space for the purpose of a public awareness promotion of business and service organizations. The Undersigned is presently maintaining, and for the duration of the above entitled agreement, will continue to maintain insurance covering any liabilities that may arise out of the operation of the booth space described above, including liability to the Expo Committee, the sponsoring Chambers and USC Verdugo Hills Hospital. Exhibitor agrees to hold the Expo and judgment recovered from or asserted against, the Chambers, USC Verdugo Hills Hospital and the City of Glendale on account of injury or damage to person or property. In the event legal action is brought to enforce this release agreement, the undersigned agrees to pay Expo, reasonable attorney's fees in connection therewith.
