FOOD VENDOR APPLICATION

A 10 x 10 foot space will be provided. The cost of the space is \$100 (or \$195 with pre-set EZ-Up, table & 2 chairs). A \$75 refundable cleaning deposit is required and will be refunded after 5 p.m. the day of the fair. An Application for Temporary Event Food Stand and Community Event Fee must be filed by 3/27/20. For the amount of the fee and the application, contact the County of L.A. Health Dept., 1101 W. Magnolia Blvd., Burbank, 91506; phone: 818-557-4187 or at www.publichealth.lacounty.gov/eh/docs/Events/FoodFacilityApp.pdf. Full payment is required to hold your space and is due by **April 1, 2020**. Spaces will be held on a first-come basis. Verification of your space will be sent to you after this form and the County Dept. of Health Application, with full payment, is received. The Chamber is unable to furnish sinks. Set-up begins at 7:30 am. Teardown of booth before 5:00 pm is prohibited. Vehicles enter the 2nd driveway on Dunsmore Ave. south of Honolulu Ave. All spaces are to be cleaned up, only **after** 5 pm. No alcoholic beverages are allowed on park grounds. Crescenta Valley Chamber has the right to restrict the type of food sold. For your protection, in case of rain or an unforeseen Act of Nature on the day of the fair, the event will be cancelled and no refund can be made (except the cleaning deposit), due to non-refundable costs to the chamber. There will be no rescheduled date.

FOR GRASS SPACE RESERVATIONS:

A 10 x 10 ft. space will be provided on a first-come basis for food vendors for \$100 plus a refundable \$75 deposit. Bring your own set-up as space does not include a structure or electricity. If rentals are needed, we suggest local rental companies, Bonners Rentals 818-951-9117. Set-up of EZ Up tents, tables, chairs, & banners will be between 5:00 and 7:30pm on Friday, April 17. Overnight security will be provided. On Saturday morning, unloading of merchandise will begin at 7:30 am, with all booths complete no later than 9:00 am. Vehicles may enter the 2nd driveway south of Honolulu Ave. on Dunsmore Ave. for unloading. You may unload your merchandise in the park, but due to safety reasons, **all vehicles need to be off the grass by 9:00 am**, and are not allowed back on until after the fair ends at 5:00 pm. **Teardown of booth before 5 pm is prohibited.** All left-over merchandise is to be cleaned up. Vendors who tear down before 5 pm or fail to clean up will lose their \$75 deposit.

FOR FULLY SET-UP BOOTH RESERVATIONS:

A 10 x 10 ft. space outfitted with EZ Up tent, 6-foot table and 2 chairs will be provided on a first-come basis for food vendor booths for \$195 plus a refundable \$75 deposit. There is no electricity. On Saturday morning (4/18/20), unloading of merchandise will begin at 7:30 am, with all booths complete no later than 9:00 am. Vehicles may enter the 2nd driveway south of Honolulu Ave. on Dunsmore Ave. for unloading. You may unload your merchandise in the park, but due to safety reasons, **all vehicles need to be off the grass by 9:00 am**, and are not allowed back on until after the fair ends at 5:00 pm. **Vacating your booth before 5 pm is prohibited.** Vendors who tear down before 5 pm or fail to clean up will lose their \$75 deposit. EZ Ups, table and chairs will be broken down for you after 6 pm.

This community event is held at Crescenta Valley Park, 3901 Dunsmore Ave., La Crescenta. No alcoholic beverages are allowed on park grounds. Crescenta Valley Chamber has the right to restrict the type of merchandise sold. For your protection, in case of heavy rain or an unforeseen Act of Nature on the day of the fair, the event will be canceled and no refund can be made (except for the deposit) due to non-refundable costs to the chamber. There will be no rescheduled date. Booth assignments are given the morning of the fair.
